Dear Parent/Carer,

RE: Ski Trip to Gitschberg-Jochtal, Italy 2020

As you may be aware, we organise a ski trip for students on an annual basis. We have provisionally booked 24 places for a ski trip to Italy on **Friday 3rd April 2020 for 9 days**. The trip will cost approximately £869 (based on 24 paying pupils; if we obtain fewer numbers then there may be a small supplement) and includes 4 hours ski instruction a day in a small group environment, 6 full days of skiing, hire of skis and boots, lift pass for the entire duration of the trip, comprehensive travel insurance and full board in a three star hotel. We will travel by executive coach and the journey could take around 24 hours to reach the resort.

If your child would like to go on this trip, a deposit of £100 will be required to secure their place. This must be returned to school by no later than **Friday 7th June 2019**, together with the reply slip at the bottom of this letter. Should this trip not take place this deposit is returnable.

Following the initial deposit, we would then need to receive the following payments over the next 12 months:

- Second deposit - £100 – Friday 5th July 2019
- Third deposit - £250 – Friday 13th September 2019
- Fourth deposit - £200 – Monday 4th November 2019
- Fifth deposit - £119 – Friday 6th December 2019
- Final deposit – £100 – Friday 10th January 2020

In order to simplify matters and to ensure that we meet the payment deadlines, we would request that postdated cheques are used for all the remaining payments. The reason for this is that if payments are not made on time, the tour companies can include a surcharge. We have in previous years been charged an additional £1000.

Recent court action against teachers acting in good faith as the 'responsible parent' on a school trip has necessitated a review of our policy on what is a sensible response to bad behaviour or disobedience.

The key points to follow are;

- We will operate a zero tolerance on any act, which could result in danger to that person or to others.
- We operate a zero tolerance on behaviour deemed unacceptable.
- In either event the pupil concerned will be sent home at short notice entirely at the parent/guardian's expense.
- Parents, trusted friend or a relative must be available at any time to collect the returned pupil. Clearly contact numbers must be provided for that purpose.

Please note that this is an energetic holiday, and it would be advisable not to allow your child to participate if you feel their health would suffer or they would not be able to complete 5 hours of physical activities per day.
